4. Presentations/ Reports



4.1. Treasurer's Report

- 4.1.1. General find is sitting around \$60K and the lottery fund at \$2304 and the benevolent is at \$1350 as of August 31st. The GIC's are at the same as before.
- 4.1.2. We paid insurance in August, which was the largest expense in August. Sponsorships were a major source of income in August.
- 4.1.3. There has been lots of activity in September. We do not have an answer about the not-for-profit bank account, Lindsay will get answers about it by the next meeting.
- 4.1.4. Dylan has been added to the account and the paperwork will be submitted shortly.
- 4.1.5. Jade will be paid \$51 from last season and it'll be added to her first pay of this season.
- 4.1.6. Too many goalie jerseys were ordered, so VMF Sports will issue us a refund for the difference. There is still an amount owed to us in the general range of \$542.
- 4.1.7. The time keeping system still needs to be established between Amanda Martin and Lindsay.

4.2. Sponsorship Update

- 4.2.1. There are still 4 team jerseys available. We have 5 brand new sponsors this year for the general sponsorships.
- 4.2.2. Sign needs is still working on the new signs.
- 4.2.3. The Zamboni is all paid for expect for 1 sponsor.
- 4.2.4. Our general sponsorship is around \$8000 already.
- 4.2.5. Katie's goal is to have all of the board signs up before the season starts.

4.3. Ice Scheduler's Update

- 4.3.1. October 10th is our first day! The schedule is all up online and set.
- 4.3.2. If Monday kids are missing the day, they have access to the Friday's buffer time. This is up to the coaches to make sure it works.
