- 1.1. U15 Osprey Game (February 29th)
 - 1.1.1. An OPP officer will be present at the next U15 game against Osprey due to issues after the last game and many previous altercations (cost is \$499.53)
 - 1.1.2. A formal complaint has been made by a U15 parent to the OMHA about the Osprey player and parent conduct after the last game
 - 1.1.3. A discussion was had about the need to have OPP present and the implications of not having them present
 - 1.1.4. A case was made about not having the U15 team pay for the OPP office at their game as it wouldn't be fair to penalize the children who worked hard to raise these funds, and because it is the organization's responsibility to ensure the safety of our Members
 - 1.1.5. Brett will request that the GBTLL reimburse this fee to alleviate the financial burden to the organization

4. Presentations/ Reports

4.1. Treasurer's Report

- 4.1.1. As of January 31 General Account was sitting at about \$32,000
- 4.1.2. Remaining known expenses are \$37,500 (mostly ice time does not include refs, skills, etc)
- 4.1.3. Successfully transferred \$5,500 from Lottery Fund Account to General Account
- 4.1.4. The Lottery Fund has enough in the account to cover bank fees until next season
- 4.1.5. The Benevolent Fund has \$2,200 for next season
- 4.1.6. Fees for AP players will be calculated at the end of the season
- 4.1.7. Total income so far this year is \$154,623 and total expenses is \$145,558
- 4.1.8. The fundraising fee should be reconsidered for next year



- 4.1.9. To help with the deficit, some fundraising can be done before the end of the year
- 4.1.10. Violet will be away in March
- 4.2. Sponsorship Update
 - 4.2.1. Almost all sponsorship plaques have been distributed
 - 4.2.2. \$2,500 still remaining to be collected from a sponsor, which should be paid by year end
- 4.3. Ice Scheduler's Update
 - 4.3.1. We successfully sold back almost all unused ice time to the arena for February
 - 4.3.2. We still have a block of ice time to sell back on March 2nd as most teams are away at games/tournaments
 - 4.3.3. First Shift program is to continue on Fridays for another 4 weeks we will sell back the hour on March 29 as the program will not be running
- 4.4. GBTLL Update
 - 4.4.1. Playoffs are underway, round robin runs until March 8th
 - 4.4.2. Finals can't be scheduled until March 16th and run until April 1st (U11 and above)
 - 4.4.3. U9 has year end tournament in Owen Sound on March 23rd
 - 4.4.4. Some arenas are pushing back against new dressing room policy that a girls' dressing room is not required even when requested (loophole)

5. Unfinished Business

- 5.1. \$30,000 GIC Renewal Options
 - 5.1.1. \$15,000 in a 2-year non-redeemable at 4.75%
 - 5.1.2. \$10,000 in a 1-year redeemable at 3.00%
 - 5.1.3. \$5,000 in a 1-year non-redeemable at 4.90% if funds not needed

- 6.5. Jerseys For Next Season
 - 6.5.1. We need to be more proactive next year with sponsorship/fundraising to try to cover the cost of jerseys and socks, possibly adding it to registration fees
 - 6.5.2. Next season U5 to U8 will get new jerseys, U9 and above can reuse jerseys if they still fit to try to save money (sponsorship patches can be changed)
 - 6.5.3. Merchant has suggested we make purchase of hoodies, pants, and jackets mandatory and these items can be sold to GVMH at cost this would ensure that items are in stock and shipped quickly
 - 6.5.3.1. Shannon will follow up with Merchant for more details about this option
 - 6.5.4. Alternatively, the organization can purchase a bulk order at cost and sell these back to the organization
