4. Presentations/ Reports



4.1. Treasurer's Report

- 4.1.1. Account update (numbers will be verified when Violet is back at the end of March)
 - 4.1.1.1. General Fund \$22,750.65
 - 4.1.1.2. Lottery Account \$169.17 (+\$255 to be added soon)
 - 4.1.1.3. Benevolent Account about \$2,200
- 4.1.2. The \$10,000 GIC hasn't been cashed yet but will be cashed on March 25th (the anticipated interest is \$260)
- 4.1.3. The \$30,000 GIC has been cashed
 - 4.1.3.1. \$15,000 was reinvested into a 1-year non-redeemable at 5.05%
 - 4.1.3.2. \$10,000 was reinvested into a 1-year prime-linked cashable at 4.75%
 - 4.1.3.3. \$5,000 has not been reinvested yet
 - 4.1.3.4. \$940.27 interest has been cashed
- 4.1.4. Going forward, there is an option is to invest a large sum into a cashable GIC to cash as needed rather than sitting in the General Account when not in use
- 4.1.5. There are still some fundraising funds coming in to help pay for the remaining end of year expenses, otherwise the \$10,000 GIC can be cashed and the remaining \$5,000 can be used rather than being invested

4.2.1. The final sponsor will be submitting the funds by the end of the season

4.3. Ice Scheduler's Update

- 4.3.1. The remaining playoff games have been scheduled for U11 and U13
- 4.3.2. A few hours were sold back to the arena after playoffs were scheduled

- 4.4.2. There will now be a scheduling meeting as usual in September to schedule the first 10 games, and then the teams will be re-seeded based on record and the final 10 games will then be scheduled by the ice schedulers
